Plagiarism Check

As mentioned in the Ph.D. Bye-laws 2014, the University had a mechanism to detect plagiarism right from its inception in 2010. Before submission, the thesis is always scanned for plagiarism through the software Turnitin.

Further, as per UGC (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations 2017, published in the Gazette of India, Part III, Section 4 (Extraordinary), the University has amended its Ph.D. Bye-laws by adopting the above mentioned UGC Regulations to check plagiarism in thesis/dissertation and research articles. The amendment was proposed in the Academic Council meeting held on 12 May 2017, and approved by the Board of Management in its meeting dated 23 May 2017.

As per the Ph.D. Bye Laws section XVI.2, the drafts of research papers and dissertation / thesis prepared by a scholar run through Turnitin to check the similarity index. The supervisor(s) will personally check the report and decide about the similarity reported with articles / documents which have been properly acknowledged and included in references. The final reports will be signed by the supervisor(s). The details of research misconduct and types of plagiarism are also mentioned in Research Ethics Policy of the University.

ITEM I TO CONFIRM THE MINUTES OF THE LAST MEETING OF THE ACADEMIC COUNCIL HELD ON 11 MAY 2016.

The Council members were informed that the minutes of the meeting of the Academic Council of The IIS University held on **11 May 2015**, were circulated to all the members of the Council vide University letter dated **10 June 2016** for comments, if any, with a proviso that in case no comments were received from them within two weeks from the date of receipt of the same, it would be presumed that minutes had met their approval.

Since no comments were received from any member of the Council, the minutes were unanimously confirmed by the Council.

ITEM II TO RECEIVE A REPORT OF THE FOLLOW UP ACTION TAKEN ON THE MINUTES OF THE LAST MEETING OF THE ACADEMIC COUNCIL OF THE UNIVERSITY HELD ON 11 MAY 2016.

The Member-Secretary Prof. Raakhi Gupta presented the report on the follow up action taken by the University on the decisions of the Academic Council taken in its meeting held on 11 May 2016. After detailed deliberations the action taken report was approved by the Council.

ITEM III TO CONSIDER THE RECOMMENDATIONS/OBSERVATIONS MADE BY THE RESEARCH BOARD IN ITS MEETINGS HELD ON 27 AUGUST 2016 AND 25 APRIL 2017

The minutes of the meeting of the Research Board held on 27 August 2016 and 25 April 2017 were considered. The Member Secretary, Dr. Raakhi Gupta

- The minutes of the Research Promotion Committee were perused by the members of Research Board. It was reported that 06 Faculty projects to the tune of Rs. 1,33,000/- (4 in faculty of Science and 02 in Faculty of Commerce & Management) and 48 Students projects to the tune of Rs. 2,27,500/- (33 in faculty of Science, 10 in Faculty of Arts & Social Sciences and 05 in Faculty of Commerce & Management) were sanctioned by the Research Promotion Committee in 2016-17.
- Approval was accorded to the panels of external experts submitted by different departments for nomination of external members on respective DRCs (or Research Advisory Committees of candidates as per UGC Regulations, 2016).
- **RECOMMENDATION FOR AMENDMENTS IN THE IISU M.PHIL./PH.D. BYE LAWS:** to be made in the light of UGC Regulations, 2016. Approval was accorded by the Research Board to the amended draft of M.Phil./Ph.D. Bye Laws.

In this regard Prof. A. B. Gupta suggested that in the individual RAC of M.Phil./ Ph.D. candidates, instead of taking two external experts, provision may be made for one expert from outside the University and one senior faculty member from the same or any other department of the University, to be nominated by the Vice Chancellor, which was unanimously agreed by the Council members. Prof. Gupta further suggested that identification of course work should also be done by RAC of the candidate, as per provisions of UGC Regulations, 2016 and if RAC is not formed in time, Supervisor(s) and Head of the Department may decide the course work which was also agreed by Academic Council members. It was decided to incorporate these suggestions in the amended IISU M.Phil./Ph.D. Bye-Laws. Prof. Gupta also suggested for considering courses available on MOOCS or other platforms for the purpose of M.Phil./Ph.D. course work, which was provided concurrence by the Council members. Prof. Vandana Chakrabarti suggested that in the chapters of

'Introduction' and 'Review of Literature', a similarity up to 20% may be allowed as sometimes it becomes difficult to keep it within 10%, particularly in the subject of Arts and Social Sciences. The member-Secretary Dr. Raakhi Gupta was, however, of the view that in subjects like Chemistry, every Chapter of thesis contains, Introduction and Review of Literature, so a relaxation of 20% similarity cannot be given in all the chapters. After deliberations, the Council authorized the Vice Chancellor to take an appropriate action in the matter as per need in this regard.

The highlights of changes made in the amended IISU M.Phil./Ph.D. Bye-laws, as approved by the Academic Council are enclosed as **Annexure-II**. A copy of the IISU M.Phil./ Ph.D. Bye laws, amended as above in the light of UGC Regulations, 2016 as approved by the Academic Council, is enclosed as **Annexure-III**. It was resolved to make the amended Bye-laws effective from the Academic Session 2017-18

The Council considered the above items and recommendations of the Research Board thereon one by one and provided its unanimous approval to the same.

ITEM IV TO CONSIDER THE RECOMMENDATIONS/OBSERVATIONS MADE BY THE BOARDS OF STUDIES OF DIFFERENT DISCIPLINES IN THEIR MEETINGS HELD FROM FEBRUARY TO APRIL 2017.

The minutes of the meetings of all the Boards of Studies held from February to April 2017 were placed before the Council. Prof. Roopa Mathur apprised the members with the changes in the curriculum, nomenclature of papers, new programmes / papers etc. and then respective Heads of the Disciplines presented their case before the Council. The Council members considered all cases pertaining to starting of new programmes/papers, closing of inactive programmes, and changes in curriculum etc., one by one and accorded their

ITEM III TO CONFIRM THE MINUTES OF THE MEETING OF THE ACADEMIC COUNCIL HELD ON 12 MAY 2017.

The minutes of the meeting of the Academic Council of the University held on 12 May 2017, were discussed in detail and the same were unanimously approved.

Specifically, the following recommendations of the Academic Council were given approval by the Board of Management:

1. RECOMMENDATIONS / OBSERVATIONS OF THE RESEARCH BOARD :

The minutes of the Research Board meetings held on 27 August 2016 and 25 April 2017, as approved by the Academic Council, were put up for approval of the Board members. The highlights of the items that were approved by the Board of Management are :-

REPORTING ITEMS

- 52 candidates were registered for Ph.D. degree between 2 February 2016 and 25 April 2017.
- Admission of 69 candidates in Research Programmes (02 M.Phil./ 67 Ph.D.) between 2 February 2016 and 25 April 2017.
- Recognition of 14 Faculty members as Research Supervisors between 2 February 2016 and 25 April 2017.

- **Subscription of Library resources-** 91 Periodicals, 155 journals, 05 online data bases & 40 e-resources by the University between 2 February 2016 and 25 April 2017.
- Organization of 15 National /International Conferences/ Seminars organized between 2 February 2016 and 25 April 2017 and the proposal for organization of 13 conferences / Seminars in the Academic Session 2017-18, approved by the Research Board and Academic Council.
- Publications of 68 research papers published in National peer reviewed Journals and 248 research papers in International Journals of repute by the University Academic Community between 2 February 2016 and 25 April 2017. The Board also provided its approval to the suggestion made by Prof. A. B. Gupta in the Academic Council meeting that the impact factor of journals and citation index of articles also be compiled along with the list of publications by the faculty and scholars of the University.
- **Presentations of research papers in Conferences:** 326 oral presentations of research papers made in National Conferences and 148 in International Conferences. Also 166 posters presented in National Conferences and 79 posters in International Conferences between 2 February 2016 and 25 April 2017.
- Award of Ph.D. degree to 45 candidates at the convocation held on 20 December 2016 and 16 Ph.D. degrees awarded after Convocation.
- The minutes of the Research Promotion Committee were perused by the members of Research Board and Academic Council.
